California Electronic Visit Verification Program New Service Codes

Effective 04/20/2023, all in home service providers contracted with AIDS Healthcare Foundations PHC Managed Care Plans must adhere to the following California Electronic Visits Verification (EVV) program changes revisions.

The Department of Health Care Services (DHCS) has established new Physical, Occupational, and Speech Therapy codes as well as Administration Intravenous and Subcutaneous codes that are impacted by EVV.

The newly added codes will be implemented on **April 20, 2023** into the CalEVV system for providers to start capturing EVV visits. **Providers will be required to use the newly added codes beginning May 1, 2023.**

Provider Self-Registration Process

Providers who have already registered do not register again. Providers will need to add beneficiary or member records or services in their CalEVV portal or Alternate EVV system. Additionally, providers will add any employee records if needed. Once beneficiary or member records are added or updated with any and all of the new services, employees will be able to select those services when needed.
