#### Summary

When coverage criteria are not fully established in Medicare statute/regulation, including National Coverage Determinations (NCDs) or Local Coverage Determinations (LCDs), the Health Plan uses alternative evidence-based coverage criteria, treatment guidelines, and clinical literature to review services for medical necessity, including InterQual guidelines. InterQual Criteria are produced using a rigorous development process based on the principles of evidence-based medicine (EBM) to provide guidance in covering both medical and behavioral health across all levels of care. Additionally, InterQual Criteria provides EBM-directed guidance that can be applied to ambulatory care planning, complex care management, durable medical equipment, procedures, and specialty pharmacy.

**Note:** *The purpose of this document is to identify medical services that may be reviewed using InterQual criteria. Information that follows uses specific words familiar to medical professionals such as doctors, nurses, psychologists, or dentists.*
